THE HOA BOARD LETTER



The vote is in and 111 homeowners voted for the resolution regarding parking in the driveways versus the garage. This is short of the 172 required to pass a change to the CC&R's. Therefore, the resolution to require homeowners to park all of their authorized vehicles in the garage did not Homeowners may park their pass. authorized vehicles in their driveways as long as they follow the rules about blocking the sidewalk, no parking on the grass, abandoned vehicles, etc. Recreational vehicles still are restricted to parking in the complex for a maximum of 48 hours in any five day period for loading, unloading, and emergency repairs. You may not live or stay overnight in your RV while it is in the complex.

The year is winding down. There will not be an HOA meeting in December. The January Board meeting will be held on January 17, 2007 and will include an election for two Board members. If you want to be a candidate, contact Jacqueline Bill at Prescott. If you want to see a change in the way the community is run, then become a Board member or join a committee.

At the last HOA meeting, the Board approved the purchase and installation of a shed. It will be located in the same place as the old shed. It will double our storage capacity. The shed will be finished in a color and texture similar to our Clubhouse and have a cement tile roof.

Several changes will be occurring at the pool. The Board approved a salt-based water treatment system to replace the chlorine system. The chlorine system will still be used for a backup as required by the City. This salt water system will help prevent the calcium build-up you see on the tiles and also prevent clouding of the pool. The Board also approved an acid wash and complete refill of the pool early next year. These maintenance steps should help keep our pool in good shape for years to come.

My two years on the Board will end on January 17, 2007. I know all of you don't agree with all of the decisions the Board makes. But I want to assure you that each time the Board makes a decision, it is with the thought that this is what the majority of community members want, or in some cases what is required by law. I hope that you feel the Board has presented an impartial view to all issues and decided issues based on facts and not personal feelings. I thank my fellow board members for their support over the last two years. I also thank all the community members who work so hard to make this community run smoothly.

I wish all of you a happy and prosperous holiday season. Thanks for making Mountain great

BOARD ACTION

- Approved minutes of October 20 meeting.
- Approved Financials for October, 2006. Total operating assets are \$39,358.41. Total reserves are \$417,208.14. Total assets are \$456.566.55. Approved a CD purchase order in the amount of \$50,000.
- Approved purchase of storage shed in the amount of \$4,024.00
- Approved repair and replacement of lighting fixtures in the pool area in the amount of \$2,400.00.
- Approved addition of color plants at the JFK gate in the amount of \$270.00
- Approved maintenance of the swimming pool to include draining acid wash, safety items addition and repair, and salt-water maintenance system in the amount of \$3,716.05. This work to be accomplished after the holidays. Notice will be given since the pool will be closed several days while the work is being accomplished.
- The Board Chairman reported that the change in the CC&R's regarding garage parking did not pass. Homeowners will be receiving a letter to that effect.
- Management reported that heating costs for the pool December, January, and February last year totaled \$3,171.81. The Board agreed to continue heating the pool and analyze costs during budget review.

December 1, 2006 is the last date to accept applications for new board members. There will be two vacancies.

COMMITTEE REPORTS

- Facilities/Landscape: Provided an update on progress of work orders. Straps will be replaced on exercise cycle equipment. Drainage channel cleaning is being discussed with the City—Fish & Game may declare the area a habitat. Debris will be blown off the tennis court weekly by Artistic Maintenance. A proposal to stain and seal the concrete at the Cactus gate and Clubhouse area was tabled to allow management to obtain more bids and information.
- Architectural Review: Ron Sais will take a leave of absence as chairman. Don MacIsaac will be temporary chairman.
- Social: November 11 dance was great fun and a repeat of that activity is being considered. Tree decorating and cookie exchange will be held at the clubhouse on December 2. Review the Social Committee page of this newsletter for details.
- Web Page: Everyone was encouraged to use the website.

THE GARDENER'S CORNER

From the gardener's corner...December weather can be deceptive. Rain, high temperatures, wind or frost are all possibilities. The days will be short and the soil will become cold. During warm spells, you can **prune** fruit trees and vines but only after all the leaves have fallen. This indicates that the plants are fully dormant and pruning will not damage living tissue. Don't clip spring blooming shrubs however or you'll remove this coming year's color – wait until the bloom is over.

I discovered new information about fertilizers during a landscaping class. The instructor told us not to buy specialty fertilizers for roses, citrus, fruit trees, etc. He says it is a marketing ploy and that we should apply only one fertilizer, whatever bag shows 16-16-16, equal parts nitrogen, phosphorus and potassium to be applied during growing season. What a relief! We no longer need to stock so many large different bags in the garage!

Roses are blooming nicely now, but don't feed them this month. Let the dying roses make rose hips which strengthens the overall bush and prepares it for winter. **Continue watering** until the rains take over. Irrigation should be reduced but not stopped as plant photosynthesis slows down and cold weather dries plants out. Speaking of irrigation, check your irrigation system monthly. Water is wasted when spray heads are broken or misaligned


We all love the holiday season because it is a time to connect and reconnect with family, friends, and acquaintances.

CRABMEAT APPETIZERS FROM MY KITCHEN

package English muffins
cans crab meat
cup shredded sharp cheddar cheese
About 1 cup mayonnaise

Onion salt Worcestershire sauce Lemon juice Salt and pepper

Split and quarter the English muffins. Drain the crabmeat and remove any bones. Mix with the other ingredients, seasoning to taste. Spread on the English muffin quarters. Broil until bubbly.

CROSTINI A LA MIA

4 ½ to 5 oz round Brie 16 oz loaf French bread 1½ cups coarsely chopped plum tomatoes 6 oz coarsely chopped cooked ham or prosciutto (about 1 cup) 2TBS olive oil 1 tsp bottled minced garlic or 2 cloves garlic, minced 1 tsp dried oregano, crushed ½ cup finely shredded Italian blend cheese 2 TBS balsamic vinegar

Preheat the oven to 350°. Using a vegetable peeler, remove edible rind from the Brie cheese. Cube the cheese and set aside. Split the French bread in half horizontally. Hollow out one of the bread halves, leaving a ½ inch shell. Place the hollowed bread half, cut side up, on a large baking sheet. Set aside. (Save the remaining bread for another use.)

In a medium bowl combine the tomatoes, ham, Brie, oil, garlic and oregano. Toss to combine. Spoon into the hollowed bread half. Sprinkle with the cheese. Bake about 15 minutes or until heated through. Drizzle with the vinegar. Cut into serving sizes.
