MEETING HIGHLIGHTS—January 30, 2013 By: Sue Janssen, Secretary

The Mountain View Homeowners Association held its Annual Meeting and Election of Board Members. Balloting was as follows: Fred Humphrey with 71 votes and Phil Roy with 102 votes. The Board welcomes Phil as our newest Board member.

Approved minutes of previous meeting.

Reviewed Delinquency Status Report:

For December 2012, the Association reports a total of \$4,415.81 in delinquent assessments. This value represents approximately a 4% delinquency rate.

Attorney authorized, by the Board, to issue Intent to Lien Letters.

Chris Bostrom from 1 Stop Pool Pros joined the meeting and discussed the recommended winter maintenance for the pool and the spa. Board approved Pool & Spa Drain/Refill & Heater Maintenance, new Pool Heater Switch. Board approved the Spa Replaster project, but because of the time it will take to be completed this project we have asked the vendor to schedule this work for next winter when the pool and spa maintenance is scheduled during January, February & March so that the pool will be in tip top condition for its opening April 1, 2014.

- Board approved Artistic Maintenance proposal to trim 18 palm trees.
- Board approved re-felting the pool table. Sign to be installed to remind players to brush table before and after use.
- Board approved 2013 Reserve Study to be conducted by Foresight Financial.
- Board approved the bid from Riverside Awning to install an awning over the patio cover outside the clubhouse doors.
- Board approved up to \$1,000.00 for the purchase of 4 new bar stools for the clubhouse tables. We will purchase metal chairs instead of wooden chairs for more security and durability.

Board discussed the bid to paint the interior of the clubhouse, billiard room, library and the fitness room. Because of the high bid we have asked management to table this project until additional bids can be procured.

Board reviewed the 2012 Facility Usage report provided by management. Findings were as follows:

Clubhouse Usage 6,103 Clubhouse Homeowners 157
 Fitness Usage 4,827 Fitness Homeowners 127
 Pool Usage 3,244 Pool Homeowners 55

Board discussed proposed projects for the community. The following were approved for further research and discussion:

- Replacing wood gate in the clubhouse parking lot with a wrought iron gate and with a fob reader for easy access to the pool.
- Refurbish the fireplace in the Clubhouse Courtyard.
- Discussion was held regarding the installation of a fire pit at the Clubhouse Patio.


